


Above cut represents our Regular Exchange Switch-Board, complete with Generator, Receiver, Transmitter, and Night-Bell attachment.

If only two instruments are to be connected, one wire is to be run from binding post marked b to binding post e, but if more than two are to be connected, they should be wired as per diagram, b to c and d to e, etc. If the terminal instruments are not far apart, the return wire may be run from a to f, (as per the dotted line), otherwise a ground connection may be made from a and f. If they are to be grounded on a gas or water pipe, wrap about two feet of bare wire tightly around the entrance pipe, and solder it well to ensure a good connection. If this is not practicable, solder the ends of the terminal wires to copper plates, each having a surface of three square feet, and place them three or four feet deep in damp earth.

For protection against lightning in all instruments except terminal ones using a ground wire, run a wire from the *centre* binding post "G" to ground, and insert plug in hole between the metal plates during a storm, taking care to remove same afterwards. In terminal instruments, where a wire already runs to ground, inserting the plug is all that is necessary.


